Exhibitors Terms & Conditions

UK Web & Mini Comix Thing 2007

Exhibitors are required to accept and sign these terms and conditions and post a copy to the organisers before they are accepted. Deviation from these terms and condition will result in removal from the event.

- 1) Civil Behaviour: I agree to conduct myself in a civil manner throughout the event taking care to accommodate the needs of those around me, to not impinge on the floor space of other exhibitors and to otherwise behave in a manner that will not within reason cause nuisance or grievance to other exhibitors, organisers and visitors.
- 2) Pornography: I agree not to attempt to sell photographic pornography. I agree not to sell comic related material depicting acts of a sexual nature between minors, children or any related variation. I agree that any comic material of a pornographic nature be declared upon this form on a separate piece of paper in a concise and general form prior to the event and displayed in a suitable cover away from the reach of children and people who are potentially easily offended. Pornographic material includes erect penises, virginal entrance, and anything that the organisers consider to be sexually lewd, potentially offensive or illegal.
- 3) I declare that I have no history or criminal record relating to the abuse of minors or sexual offences, and if a history does exist I will declare such matters in a concise and general form on a separate piece of paper.
- 4) I accept full liability for my actions on the day and am aware that under no conditions are the organisers of the event or the owners of the venue liable for and loss or damage to body, property or any other such matter that may occur.
- 5) I agree to arrive at the event no later than the agreed opening time for exhibitors and to leave no later than the agreed finishing time and take full responsibility for ensuring that I take home all rubbish, or otherwise dispose of all my rubbish in an appropriate manner.
- 6) I accept that these terms and conditions might change during the build up to the event to incorporate important issues not covered in these terms and conditions and in agreeing to these terms and conditions I am agreeing to all future terms and conditions that may be drawn up regarding the event accepting in fact that the organisers of the event will make every effort to inform me of changes, but nonetheless being bound to said terms and conditions as should be drawn up by the organisers.
- 7) I agree to abide by the rules and regulations set down by the owners of the venue and to abide by direction from officials representing the owners of the venue. I agree to accept direction from the organisers of the event, and accept that decisions made by the organisers regarding my conduct, position, and actions is final, to which there is no redress.
- 8) I agree not to falsely represent the organisers of the event in any way both before, during and after the event and shall present myself in all related communications as an exhibiter.
- 9) I agree to make myself available for one hour during the event to assist with official duties related to the running of the event, and if I cannot do so, I will detail the reasons on a separate piece of paper. An acceptable excuse is being the only adult exhibitor associated with a table.
- 10) I agree not to allow more than one other person at a time behind my table and am responsible for the actions of those allowed behind my table.
- 11) I agree to report any suspicious activity relating to any matter whatsoever associated with the event both before the event and during the event to the organisers at the soonest possible opportunity.
- 12) I acknowledge that refunds are at the discretion of the organisers.
- 13) I understand that all exhibitors and sub-exhibitors under the age of 18 must make their age known to the organisers prior to booking.
